He was speaking after inaugurating a function held here for distribution of prizes of various contests relating to the cultural panchayati and global Onam 'pookalam' conducted by the Tourism Department as part of the week-long Onam

celebrations organised by the Kerala Government.

"A symbol of resilience, hope and equality, Onam has become a significant product that can attract domestic and foreign tourists. With the formation of tourism clubs in some foreign cities including London, the Tourism department has already initiated efforts to market the next year's Onam globally.

By prominently projecting the unique features of various destinations, we will be able to

ensure greater flow of tourists to the state from across the world during the Onam season," the Minister said.

Presiding over the function, Transport Minister Antony Raju lauded the efforts of the Tourism department and the public in making the Onam celebrations a state-wide success.

"The large public participation during this Onam was commendable and it made the celebrations outstanding", he said.

# Kerala tourism sees 196% increase in arrivals

Tiruvandrum, Nov 26: Kerala made a record-setting 196 per cent surge in domestic tourist arrivals in the first three quarters of the current year as compared to the corresponding period a year ago, reflecting a spectacular comeback from the pandemic-triggered downturn, Tourism Minister P A Mohamed Riyas said on Friday.

Sending clear signals that Kerala's crucial travel and hospitality sector is poised to surpass pre-pandemic levels, the state received a total of 1,33,80,000 domestic tourists in nine months till this September, notching a 1.49 per cent increase as compared to the same period before COVID-19 struck the world, the Minister told a press conference here.

What is more, this impressive performance

shows a 196 per cent jump against the corresponding period last year, reflecting the success of the efforts made by the state including the marketing campaigns it mounted in India and abroad, Riyas said.

Also, the January-September period this year saw a 600 per cent stride in foreign tourist arrivals to Kerala, and the state is expected

to host more overseas travelers as the world is opening up overcoming the pandemic-induced restrictions.

Kerala's caravan tourism, Keravan Kerala, launched during the pandemic period, will be further developed as it has tremendous scope to attract foreign tourists. As part of this, plans are afoot to develop caravan parks in Bolgatty and Kumarakom, the Minister said.

# Aero Mall now in Pune airport

Pune, Nov 26: Union Civil Aviation and Steel Minister Jyotiraditya Scindia inaugurated a multi-storied Aero Mall at Lohegaon Airport in Pune. The project is multi-level car parking with integrated commercial complex.

Speaking on this occasion, Union Civil Aviation Minister said that the work of the new building and cargo facility of Lohegaon Airport

will be completed in the next 6 months. Direct flights to Bangkok Pune have been started and next month direct flight service to Singapore will be started. The Civil Aviation Minister promised to increase the number of flights from Pune. Currently 1,600 flights operate from Pune airport per week; we are soon going to increase the number of flights. The Minister further said that Pune will

also be developed like Mumbai. Cities like Gwalior, Pune and Kolhapur are very important cities for me. Various projects will be planned for their development?.

New multi-level parking will resolve the issue of parking at Pune airport. Built at a cost of Rs 120 crore, the five-storey Aero Mall will have parking facilities for around 1,000 four-wheelers and two-wheelers. This mall has been built in a total area of 4 lakh 50 thousand square feet, out of which 3 lakh square feet of space is used only for parking and the remaining 1 lakh 50 thousand square feet of space is used for commercial purposes.
