Agriculture and Farmers Welfare Minister M.R.K. Panneerselvam inaugurates the Periyar Memorial Samathuvapuram housing units constructed by the Rural Development and Panchayat Raj Department at Poovanikuppam in Kurinjipadi Panchayat Union, Cuddalore district, on Thursday. Collector C.P. Adithya Senthilkumar, Additional Collector (District Rural Development Agency) R.A. Priyanka, and others are present.

# Minister opens samathuvapuram in Kurinjipadi Panchayat

Cuddalore, Feb 7: Agriculture and Farmers Welfare Minister M.R.K. Panneerselvam on Thursday inaugurated the Periyar Memorial Samathuvapuram housing units constructed at Poovanikuppam in Kurinjipadi Panchayat Union of Cuddalore district at a total cost of Rs. 8.55 crore.

Earlier in the day, Tamil Nadu Chief Minister M.K. Stalin inaugurated the housing project through video conferencing. Following this, the Minister formally opened the Samathuvapuram in the presence of District Collector C.P. Adithya Senthilkumar and distributed house allotment orders to the beneficiaries.

Addressing the gathering, the Minister recalled that former Chief Minister M. Karunanidhi launched the Samathuvapuram scheme during 1997-98 to promote social equality by enabling people from all communities to live together without caste or religious discrimination, in line with the principles of Periyar. A total of 240 Samathuvapurams were established across Tamil Nadu under the scheme.

He said the present Chief Minister M.K. Stalin has been taking several initiatives to strengthen social harmony, eliminate caste-based residential segregation and promote an egalitarian society by renovating existing Samathuvapurams and constructing new ones.

Under the Periyar Memorial Samathuvapuram scheme, 100 houses have been constructed at Melapooavanikuppam village, each on a five-cent plot with a built-up area of 300 sq. ft., at a cost of Rs. 6.73 lakh per house, amounting to Rs. 6.73 crore.

In addition to housing, several infrastructure facilities have been provided for the benefit of residents, including a park and playground, an overhead water tank with a capacity of 30,000 litres, internal roads, streetlights, borewell with pump set, drinking water connections for all houses, main road improvements, link roads, cattle fodder garden access road and a small bridge.

The Minister also said that in Cuddalore district, 54 works undertaken by the Rural Development and Panchayat Raj Department at a total cost of Rs. 22 crore, including Panchayat office buildings, Panchayat secretariats, additional classrooms in government schools, anganwadi centres and health centres, have been completed and opened for public use.

He further highlighted various flagship welfare schemes implemented by the State government, including the Kalaigiar Magalir Urinai Thittam, Vidiyal Payanam for Women, Pudhumai Penn, Tamil Pudhalvan, Chief Minister's Breakfast Scheme and the Innuayir Kappom - Nammai Kaakkum Stalin Scheme, and urged people to extend their support for these initiatives.
